## **Business and Farm Energy Planning**

### What Is The Energy Planning Program?

The Business and Farm Energy Planning Program is funded by a grant from the USDA Rural Energy for America Program. It provides technical assistance to eligible farms and small businesses in nine counties in northeastern Iowa and two counties in southeastern Minnesota. Local Energy Districts collaborate with Winneshiek Energy District and Luther College to:

- 1. Conduct outreach to identify farmers and small business owners motivated to learn about and invest in cost-effective energy efficiency and solar energy projects.
- 2. Conduct high-quality technical assistance energy auditing and planning that pinpoints cost-effective clean energy opportunities, identifies financial assistance options, and assists in getting practices and projects implemented.
- 3. Works with the participant to share their story with peers and the community, to build awareness and momentum towards locally-owned clean energy prosperity.

#### **How It Works**

- 1. Sign up for the program on the next page. (Funds are limited. Applicant eligibility is outlined on the next page.)
- 2. If enrolled, an Energy Auditor/Planner will be in touch to collect information on your operation and goals, conduct a site visit, and follow up to discuss the results and cost-effective opportunities for energy efficiency and/or solar energy.
- 3. As you make decisions about what practices to implement and when, local Energy Districts and other partners will be in touch to discuss sharing opportunities, such as video stories, field days, efficiency tours, or other activities that work for you.


## **Required Cost-Share**

The energy audit and investment plan are comprehensive of all energy sources and uses, and include solar site assessment if desired. Grant funds cover 75% of the cost, but USDA program rules require participants to pay 25% cost-share for the audit and planning process. The **participant cost** varies depending on scale and complexity of the business:

- \$250 for most small businesses (under 20,000 sf and \$20,000 in total annual energy expenses); \$500 \$750 for larger or more complex commercial establishments
- \$600-800 for most farm operations; \$850-\$1,000 for larger or more complex farms
